Blatant Double-Standard Performing FBI Investigation: Strike One—The Confidential “Walk-in”

By 22 February 2016, the FBI Washington Field Office Memorialized Information Provided by a Visitor Who Had Been Interviewed on 27 January 2016 (HRC Dump 6 of 16, pages 11-12):

“On 27 January [2016], writer spoke with [unknown, who] explained to writer **he had sent evidence of Hillary Clinton’s misuse of classified documents to the FBI Director earlier in January 2016, BUT WHEN HE CALLED TO CONFIRM RECEIPT HE COULD NOT DO SO** and therefore wanted to walk-in to make sure the information was received by the right people at the FBI, Specifically the “task force” working on the Clinton e-mail scandal.

[Unknown] explained he was a long-time government employee and had previously worked for many years at the Department of State. He provided a resume and a U.S. Foreign Service Employee Evaluation Report to prove his *bona fides*.

[Unknown] did not go into detail as to what the evidence was as he had provided other typed documents explaining the evidence to the unclassified level. HE OFFERED TO BE INTERVIEWED IN A SCIF SO HE COULD TALK AT A HIGHER CLASSIFICATION TO FURTHER EXPLAIN OTHER EVIDENCE.

All of the documents provided by [unknown] are being attached as a 1A for further review by the appropriate personnel reviewing this matter.”

Blatant Double-Standard Performing FBI Investigation: Strike Two-**LOTS OF DAMN EMAILS KNOWN TO FBI LINE AGENTS**

On 15 July 2016, **10 DAYS FOLLOWING FBI DIRECTOR COMEY'S "EXONERATION" PERFORMANCE**, a memo to the file is entered in the Washington Field Office Records (HRC Dump 6 of 16, pages 53-54):

"The instant communication documents and analysis conducted by the author regarding the Department of State (DoS) tenure e-mail correspondence between the personal accounts of HILLARY CLINTON (hdr22@clintonemail.com) and HUMA ABEDIN (huma@clintonemail.com). The author analyzed e-mail correspondence across various datasets acquired by the FBI during the course of the investigation. **Ultimately, the author identified 1,539 direct emails between the hdr22@clintonemail.com and huma@clintonemail.com (i.e. no other email address was party to the email communication) WHICH WERE NOT PROVIDED TO DoS BY CLINTON IN DECEMBER 2014, BUT WERE ASSESSED BY THE FBI TO BE WORK-RELATED.**

Analysis of the emails provided to DoS by CLINTON in December 2014 indicated huma@clintonemail.com was party to 2,598 total emails in the dataset. However, of the 2,598 emails, only 32 were direct communications exclusively between huma@clintonemail.com and hdr22@clintonemail.com. The author determined each of the 32 e-mails contained references to either "Benghazi," "Libya" or "Tripoli." Consequently, the 32 e-mails were provided to DoS because they hit on those search terms, rather than a search of huma@clintonemail.com. **As a result, the process used by CLINTON's legal team to determine which of CLINTON's DoS tenure e-mails were work-related was POSSIBLY FLAWED IN ITS HANDLING OF E-MAIL CORRESPONDENCE BETWEEN CLINTON AND ABEDIN'S huma@clintonemail.com address.**"

“Even as Hillary’s scandals finally began to permeate the news, she continues to benefit largely from a sympathetic and supportive press. According to my sourcing, **the *New York Times* has obtained BLOCKBUSTER information about the Clinton Foundation that the FBI has been intensely probing the charity. But the newspaper has decided to sit on it. In contrast, there’s no such plan at the *New York Times* to protect Donald Trump. The *Times* reports on assorted scandals around his charity. The Trump Foundation is relatively small: it took in about one-half million dollars in 2013, compared to the Clinton Foundation’s \$150 million the same year. That makes the global Clinton Foundation roughly three hundred times larger than [the] Trump Foundation in terms of finances, not to mention the fact that Clinton’s charity is run by an ex-president and a former secretary of state who were dealing with sensitive foreign countries seeking favor on policy and financial issues. Yet, **while the *Times* sits on news of the FBI investigation into the Clinton Foundation, it finds it much more newsworthy that Trump’s charity paid \$20,000 for a portrait of Trump and the *Times* jumps on the news when the New York attorney general Eric Schneiderman, a Clinton supporter opens an [aptly] timed investigation into the Trump Foundation.** In other words, the *Times* goes after Trump on relatively small issues while staying mum on the more serious FBI investigation into the Clinton Foundation.

This investigation began as a result of a review of e-mails undertaken by the U.S. Department of State (State Department) in connection with Freedom of Information Act (FOIA) litigation. During this FOIA review, it was determined that certain e-mails containing classified information were sent and received on systems unauthorized for the transmission or storage of such information. ON OR ABOUT 6 JULY 2015, THE INSPECTOR GENERAL FOR THE INTELLIGENCE COMMUNITY NOTIFIED THE FBI OF A POTENTIAL COMPROMISE OF CLASSIFIED INFORMATION INVOLVING THE E-MAILS DISCOVERED THROUGH THE FOIA REVIEW. AFTER AN INITIAL REVIEW OF THE MATTER, THE FBI OPENED A CRIMINAL INVESTIGATION [ON 10 JULY 2015] to , among other things, identify any unauthorized systems which the e-mails in question have transited, identify any person(s) who may have introduced classified information onto unauthorized systems and all circumstances surrounding such introduction, identify any person(s) who may have transmitted such information over any such systems, and identify whether classified information has been compromised through [add] intrusions or unauthorized access into these systems.”</p>
